壹、 外國學生申請入學資訊 International Student Admission Information

一、申請資格 Eligibility

● 身分規定 Applicant's Identity

(一) 具外國國籍並未曾具有中華民國國籍，符合下列規定者。

An individual of foreign nationality, who has never held nationality status from the Republic of China ("R.O.C.") and who meets the following requirements, is qualified to apply for admission.

1. 未曾以僑生身分在臺就學

An individual has never undertaken studies in Taiwan as an overseas Chinese student.

2. 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

An individual has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

(二) 具外國國籍且符合下列規定，且最近連續居留海外六年以上者(計算至 2026 年 8 月 1 日)。

An individual of foreign nationality, pursuant to the following requirements and who has resided overseas continuously for no less than 6 years (up to August 1, 2026) is also qualified to apply for admission.

1. 申請時兼具中華民國國籍，應自始未曾在臺設有戶籍。

An individual who also is a national of the R.O.C., but does not hold nor has had a household registration in Taiwan.

2. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年(計算至 2026 年 8 月 1 日)。

An individual who also was a national of the R.O.C. but has no R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years (up to August 1, 2026) after an annulment of R.O.C. nationality by the Ministry of the Interior.

3. 前二款未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。

以上所定六年、八年，以擬入學當學期起始日期為終日計算之。所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

(1) 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

(2) 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

(3) 交換學生，其交換期間合計未滿二年。

(4) 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an overseas Chinese student nor received placement permission during the same year of the application by the University Entrance Committee for Overseas Chinese Students.

The six year calculation period as prescribed above shall be calculated from the starting date of the semester as the designated due date for the time of study.

The term “overseas” as prescribed above is limited to countries or regions other than Mainland China, Hong Kong and Macau; the term “reside overseas continuously” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year. If the calculated calendar year is not one complete calendar year, their stay in Taiwan should not exceed 120 days within the calculated calendar year period. The only exceptions to this method of calculation are for those who fulfill one of the following requirements with written supportive proof:

- (1) Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technique training classes accredited by the Ministry of Education;
- (2) Attended a Mandarin Chinese language center at a university/college of which foreign student recruitment is approved by the Ministry, and to which the total length of stay is less than 2 years;
- (3) Exchange students, whose length of total exchange is less than 2 years;
- (4) An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than 2 years.

(三) 具外國國籍且原具中華民國國籍，並於外國學生來臺就學辦法中華民國 100 年 2 月 1 日修正施行前（2011 年 2 月 1 日前）已提出申請喪失中華民國國籍滿八年者（計算至 2026 年 8 月 1 日），得依原規定申請入學，不受前點規定之限制。

An individual, who has foreign nationality and had applied for an annulment of the R.O.C. nationality prior to February 1, 2011 (the effective date of this amendment of Regulations Regarding International Students Undertaking Studies in Taiwan issued by the Ministry) for at least 8 years since the date, on which a revocation was issued from the Ministry of the Interior, up to August 1, 2025, will then be qualified to apply for admission as an international student under the amendment effective before Feb.1st, 2011 and will not be subject to the limitation of the preceding clause.

※以上所指中華民國國籍係依國籍法第二條規定辦理。

有下列各款情形之一者，屬中華民國國籍：

- 1、出生時父或母為中華民國國民。
- 2、出生於父或母死亡後，其父或母死亡時為中華民國國民。
- 3、出生於中華民國領域內，父母均無可考，或均無國籍者。
- 4、歸化者。

R.O.C. nationality is defined in accordance with Article 2 of the Nationality Act:

A person who meets one of the following requirements has acquired nationality of Republic of China:

1. A person whose father or mother was, at the time of his (her) birth, a citizen of the Republic of China.
2. A person born after the death of his (her) father or mother who was, at the time of his (her) death, a citizen of the Republic of China.
3. A person born in the territory of the Republic of China and whose parents are both unknown or are stateless.
4. A naturalized person.

- (四) 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者，得依規定申請入學。所定六年及所稱海外連續居留準用第二點第三項規定。

An applicant of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao, or overseas continuously for no less than 6 years is qualified to apply for admission. The six-year calculation and the term “resided overseas continuously” mentioned here shall be subject to the preceding second paragraph of the third clause.

- (五) 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者，得依規定申請入學。所定六年及所稱海外連續居留準用第二點第三項規定。

An applicant being a former citizen of Mainland China and holds a foreign nationality, having no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than 6 years is qualified to apply for admission.

The six-year calculation and the term “resided overseas continuously” mentioned here shall be subject to the preceding second paragraph of the third clause.

● **學歷規定 Applicant’s Academic Credentials**

7. 注意事項 Miscellaneous

1. 本項入學辦法經 115年1月07日臺教文(五)字第1140133927號函核定。The admission of international students to VNU is conducted in compliance with Ordinance No. 1140133927 issued by the Ministry of Education (MOE) on January 7th, 2026 subject to any changes that may come into effect by the last day of application.
2. 外國學生若有違反下列情事者，經查證屬實，不符申請資格者，撤銷其所獲准之入學資格或撤銷學籍: International students admitted to VNU shall be revoked of their admission and/or dismissed from VNU if any of the following terms is violated:
 - (1) 不具中華民國國籍之華裔外國籍學生，應依本身條件擇以「外國學生來臺就學辦法」或「僑生回國就學及輔導辦法」申請入學，不得同時以僑生及外國學生身分申請入學者。Students who do not possess ROC nationality shall apply for admission to VNU in the capacity of either an overseas Chinese or a foreigner, but NOT in both capacities.
 - (2) 曾具中華民國國籍及外國國籍之雙重國籍者，自內政部許可喪失中華民國國籍不足 8 年。Students who are ex-ROC citizens shall not apply for admission to an ROC college or university as international students within eight years after their ROC nationality is denied.
 - (3) 具外國國籍兼具中華民國國籍並未在臺灣設籍。Students who hold Republic of China nationality at the time of application should not have a registered permanent residence of Taiwan.
 - (4) 自國內各大專院校畢業或入學學校以操行不及格或學業考核未達規定、違反法令或校規情節嚴重致遭退學或喪失學籍者，。International students shall have never been expelled from a university or college in R.O.C. due to failure in conduct grades, academic grades, or being indicted guilty by the criminal law.
3. 外國學生依據「教育部外國學生來臺就學辦法」申請來臺就學者，以一次為限。如繼續在臺就學者，其入學方式應與我國內一般學生相同。但下列情形，不在此限：An international student applying to study at an educational institution in Taiwan in accordance with the provisions of the two previous articles is limited to only applying once. If a student wants to continue studying in Taiwan, their application shall be handled in the same manner as the admission procedures for domestic students. However, this requirement does not apply to an international student in either of the following circumstances:
 - (1) 於完成申請就學學校學程後，申請碩士班以上學程，逕依本規定辦理。 If an international student is applying for admission to a master's degree or higher-level program after completing the course of study at the educational institution to which they originally applied, the university to which the student is now applying shall handle the application in accordance with its regulations;
 - (2) 外國學生申請來臺就讀學士班以下學程，在國內停留未滿一年，因故退學或喪失學籍，得重新申請來臺就學，並以一次為限。If an international student applied to come to Taiwan to undertake a bachelor's degree or lower-level program in Taiwan and after coming to Taiwan stayed for less than one year for some reason then discontinued their studies or forfeited their student status, that student may lodge another application to come to Taiwan to study, but only one such re-application is permitted.外國學生經入學學校以操行或學業成績不及格、違反法令或校規情節嚴重致遭退學或喪失學籍者，不得再依前項規定申請入學。If an educational institution in Taiwan where an

international student was studying considers that their conduct or academic performance was unsatisfactory, or if the student seriously violated any ordinances or the regulations of the educational institution and the circumstances were serious and as a result, in accordance with the provisions of its regulations governing student awards and penalties had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan on the basis of the provisions of the previous paragraph.

4. 外國學生不得申請就讀本校碩士在職專班及其他僅於夜間、例假日授課之班別。但外國學生已在臺領有外僑居留證、永久居留證或其就讀之班別屬經教育部專案核准之國際性課程者，不在此限。An international student is not permitted to apply to study any recurrent or continuing education bachelor's degree program or in-service master's degree program, or any other program which is only taught in the evening or during vacations, at a university or tertiary college in Taiwan. However, an international student who already has legitimate resident status or who is undertaking a program approved on a case by case basis by the Ministry of Education is not subject to this restriction.
5. 外國學生保留入學資格、轉學、轉系（所、組）、休學、退學及其他學籍、學業、生活考核等事項，均依有關法令規定辦理。International students' retention of admission qualifications, transfer of schools, transfer of departments (institutes, groups), suspension of study, withdrawal from school and other matters such as student status, academic and life assessments shall be handled in accordance with relevant laws and regulations.
6. 申請人僅能申請一系/所。Applicants can only apply to one department/institute.
7. 外國學生應依「大學辦理國外學歷採認辦法」、「大陸地區學歷採認辦法」、「香港澳門學歷檢覈及採認辦法」繳交相關學歷證明文件。具高中畢業資格者，得申請入學本校學士班；具學士學位者或具有與我國學制相當之同等學力資格者，得申請入學本校碩士班。International students applying for admission shall submit academic credentials:
 - (1) Academic credentials from the Mainland Area: shall be handled in accordance with the provisions of the Regulations Regarding the Assessment and Recognition of Academic Credentials for Mainland Area.
 - (2) Academic credentials from Hong Kong or Macao: shall be handled in accordance with the provisions of the Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao.
 - (3) Academic credentials from other areas:
 - A. Academic credentials issued by an Overseas Taiwan School or a school for Taiwan business people in the Mainland Area shall be regarded as equivalent to academic credentials issued by an educational institution of the same level in Taiwan.International Students with high school graduation qualifications may apply for admission to the Bachelor Degree Program, and those with bachelor degree or equivalent academic qualifications equivalent to Taiwan academic system may apply for admission to the Master Degree Program.

畢業年級相當於國內高級中等學校二年級之國外或香港澳門地區同級同類學校畢業學生，以同等學力資格入學者，應在規定之修業年限內增加其應修之畢業學分數 16 分(12 學分專業選修，4 學分知性通識)。Students from foreign countries, Hong Kong or Macau, who graduate from schools of the same type and level that are equivalent to second year students in a high school in Taiwan have the same academic qualifications to enter school and must add 16 credits to the total credits required for graduation within the specified amount of time allowed to complete the degree.
